

Minutes of a Meeting of the Joliet Township Board 175 W. Jefferson St., Joliet, IL 60432 Tuesday, February 9, 2021

The regular town board meeting, being held at 175 West Jefferson Street, Joliet Township government offices, Tuesday, February 9, 2021, at 5:00 p.m. was called to order by Supervisor Daniel L. Vera.

## **Approval of the Minutes:**

<u>Regular Town Minutes/January 26, 2021</u>: Trustee Slattery moved to approve the minutes of the January 26, 2021 Town Board Meeting, and to waive the reading of these minutes inasmuch as copies had previously been delivered. Seconded by Trustee Verdin. A roll call vote was taken.<sup>1</sup>

## **New Business:**

Approval/Clarke Mosquito Abatement Contract- A motion was made to approve the 2021 Clarke Mosquito Abatement contract for \$41,364.00 by Trustee Slattery and was seconded by Trustee Gavin. Discussion of the cost and if any other vendors were available for this service determined that this was a professional service with a proprietary product that was not available by other local vendors. Finance Director Witt noted that the cost was a 9% increase over the last contract with Clarke. It was also

noted by Trustee Gavin that it appeared that the contract had a couple typographical errors of the year being listed as 2020 instead of 2021. Supervisor Vera stated that he would make sure that the misprinted year typos would be corrected with the contractor. Roll call vote was taken.<sup>2</sup>

Approval/YMCA Youth Grant: A motion was made to approve a YMCA Youth Grant in the amount of \$25,000.00 by Trustee Gavin and was seconded by Trustee Verdin. Supervisor Vera noted that the Township has partnered with the YMCA for many years to help with the Kids Zone program. Vera also noted that these funds were already accounted for in the budget. Roll call vote was taken.<sup>3</sup>

## **Reports:**

Supervisor Vera: Supervisor Vera reminded board members that the reports from General Assistance, Joliet Township Animal Control, Cemetery Report, and the Highway Commissioner were already received by the board in their board packets. Vera reported working on the YMCA grant and the routine operations.

Town Clerk: Clerk Kinsella reported just day-to-day operations.

Finance Director: Director Witt reported that financial statements are complete through January 31st and a copy of them was placed in each of the board packets. Bank reconciliations for January are also complete and are available in the office for review. She reported that she had emailed the January financial reports as well as the reconciled bank statements for to the Highway Commissioner earlier today (February 9, 2021). Director Witt also filed the January unemployment report as well as filed and paid the January IMRF report. Other than that, just day-to-day operations.

Attorney Harvey: Attorney Harvey reported routine matters as needed.

<u>Assessor:</u> Assessor Brenczewski reported starting the process over again, and working on the new program transferring over, and other than that just day-to-day.

<u>Highway Commissioner:</u> Commissioner Turnbull had nothing to add to his report other than stating that just the snow and cold which had already been covered.

**Receipts:** Trustee Slattery made a motion to deposit all cash receipts into their proper accounts as presented for the period ending February 9, 2021. Seconded by Trustee Gavin. Roll call vote was taken.<sup>4</sup>
