ADOPT/Resolution No. 2024-03 to Appoint a New Township Supervisor

Trustee Escutia reads Resolution No. 2024-03 to the audience as follows:

JOLIET TOWNSHIP BOARD OF TRUSTEES WARRANT OF APPOINTMENT

WHEREAS, Angel Contreras was elected as the Joliet Township Government Supervisor, on April 6, 2021; and,

WHEREAS, Angel Contreras, on July 12, 2024, resigned from the Joliet Township Supervisor's position effective July 12th; and,

WHEREAS, in doing so Angel Contreras resigned his position as Township Supervisor which created a vacancy in the Supervisor's office; and,

WHEREAS, the vacancy was created and the Township Trustees desiring to have the advice and counsel of Alicia Morales as Township Supervisor, take the following action.

NOW, THEREFORE, be it resolved by the Board of Trustees of Joliet Township, that Alicia Morales is appointed Township Supervisor of Joliet Township to fill the vacancy, effective July 16th, 2024. The Town Deputy Clerk is directed to issue forthwith a certified copy of this Warrant of Appointment and deliver the same to the said Alicia Morales, notifying her of her appointment as Township Supervisor of Joliet Township.

"I, <u>ALICIA MORALES</u>, having been appointed to the position of <u>SUPERVISOR</u> in the <u>TOWNSHIP OF JOLIET</u> in the <u>COUNTY OF WILL</u>, <u>DO SOLEMNLY SWEAR</u> or affirm, that I will support the Constitution of the United States and the Constitution of the State of Illinois, and that I will faithfully discharge the duties of the office of <u>JOLIET TOWNSHIP SUPERVISOR</u> to the best of my ability, so help me God."

Honorable Judge Vincent F. Cornelius congratulates Supervisor Morales and signs the Oath of Office this 16th Day of July, 2024.

APPROVE/Designation of Person(s) as Bank Account Signatories

Supervisor Morales asks for a motion to approve the Designation of Person(s) as Bank Account Signatories. Trustee Escutia motions. Seconded by Trustee Slattery. A roll call was taken. Motion carried.⁶

PUBLIC COMMENT: Larry Crawford from Precinct 12 stated that he did not believe it was the best approach to move PUBLIC COMMENTS after NEW BUSINESS so that opinions that may be contrary to the proceedings may not be heard by the Trustees. Mr. Crawford is disappointed for that reason and brought up his concerns based on the rapid timeframe that it took to make the decision to appoint a new Township Supervisor. Aside from his concerns, Mr. Crawford congratulated Supervisor Morales for her new position. Sandra Aguirre from Joliet Township District 86 Board Member at large and Committee woman of Precinct 13 congratulates Supervisor Morales for the new position. Ms. Aguirre states that Mr. Contreras did a wonderful job and is proud of both. Ms. Aguirre shares to the audience that Supervisor Morales is the best, strongest, amazing and intelligent woman to do the job. The Joliet Township Highway Commissioner Vincent Alessio states how he understands the difficulty in the transitioning period for the entire Joliet Township staff and is proud at the way the staff has been handling it as far. The Highway Commissioner also thanked the road workers from the County, the City of Joliet, IDOT, all the electrical power workers, as Mr. Alessio is a former IBEW Local 9 member, and the Road District for everything they have done. The Highway Commissioner is proud of Mr. Contreras and considers him one of his biggest influences and is happy to continue the role as Highway Commissioner with Supervisor Morales.
