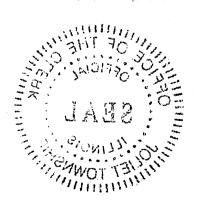

ORDINANCE No. 2024-03 (RD)

An ordinance appropriating for all town purposes for **Joliet Township Road District**, Will County for the fiscal year beginning **April 1, 2024** and ending **March 31, 2025**.

BE IT ORDAINED by the Board of Trustees of Joliet Township, Will County, Illinois.

Six Hundred and Fifty Dollars (\$2,933,650.00) for the fiscal year beginning

April 1, 2024 and ending March 31, 2025.

SECTION 6: That section 3 shall be and is a summary of the Annual Appropriation Ordinance of this Road District, passed by the Board of Trustees as required by law and shall be in full force and effect from and after this date.

SECTION 7: That a certified copy of the Budget & Appropriation Ordinance must be filed with the County Clerk within 30 days after adoption.
